## Reflections: An R42 Looks Back

After 42 years my medical career has become a bit of a blur. So much has changed. Medical records were piles of loose-leaf papers stuffed randomly into multiple folders. Computers were rudimentary research tools. Imaging was limited to basic plain films. The nearest CT was in Albany. MRI was still over the technological horizon.

I distinctly remember that first day of the journey, walking up the hill from Fernleigh Over with my imposter syndrome at full volume. My first night on call was spent in the ER in what is now the Clark Auditorium. There was a small trailer outside with a call room. The rotary [!] telephone was directly over the head of the bed. I was so petrified of its ringing and being found out as a complete incompetent.

I suppose everyone has at least one significant mentor. This supposition is dangerous territory to reflect upon given the abundance of the many truly exceptional clinicians with whom I was privileged to work but Bob Sioussat stands out in my memory. He (and

Mable Baker, R.N.) ran the old “Ambu” clinic. Like most internists of that time, he also had a subspecialty interest—neurology in his case. He and his wife, Robin, lived in a rambling old house on Susquehanna Avenue. They had a pontoon boat on the lake, and I still remember one cruise listening to the community band anchored off the great lawn of The Otesaga on a summer evening. In Ambu clinic I learned the power of relationships, which ultimately allowed me to practice general internal medicine all these years.

Another powerful memory that frequently floats up into my consciousness is seeing Emery Herman late one Sunday morning after “services” (the common term for weekly tennis games at his place) rounding on his patients in the hospital. He wore his white coat but otherwise came straight from the courts. So, from the rear he made for a perfect image of a flasher with his bare legs. I have tried to emulate Emery’s devotion to his patients ever since.

## Surgery Resident Joined Alumni Board

Dr. Elizabeth Jacob, in her third year of surgery residency at Bassett, has been serving as a member of the Bassett Medical Alumni Association Board of Directors since the fall of 2019.

Jacob was first introduced to the Bassett Medical Alumni Association when she met with the Board of Directors to discuss Resident Wellness initiatives that were funded by the Alumni Association in response to low morale among residents. ## New Program Director of Surgery Residency Appointed

Dr. Joon K. Shim joined Bassett's Department of Surgery in January as attending physician and its residency program director. Born in South Korea, at age six, she emigrated with her family to Edgewater, N.J., where she grew up.

Shim earned a bachelor's degree in philosophy at Bryn Mawr College and received her medical degree from George Washington University School of Medicine, from which she also received a master's degree in public health. Having completed her surgery residency at the University of Massachusetts, she served four years as staff/combat surgeon in the U.S. Army with three tours of duty in Afghanistan. She ascended to the rank of Major, and for her outstanding service, she was awarded the Army's Meritorious Service Medal.

She went on to complete a Minimally Invasive Surgery/Bariatric Surgery fellowship at Alpert Medical School of Brown University and then joined the surgery faculty of Wright State University Boonshoft School of Medicine as an assistant professor and subsequently associate clerkship director as well as a residency site director at Miami Valley Hospital. With a strong

interest in the interface between Medicine and the Arts, she has completed an Art Museum-based Health Professional fellowship through the Cambridge Health Alliance-Harvard University program.

Shim hopes to further enrich the training of our students and residents with an increased focus on the humanities and arts and their importance in medicine. Dr. Drew Griffiths, who served as interim program director until her arrival, will continue in his role as Bassett's associate program director for surgery and looks forward to working closely with Shim. She is the author of an impressive list of peer-reviewed articles and has a long list of poster presentations to her credit. She and her husband, Jonathon Pincus, an adjunct instructor of art at State University of New York in Oneonta, are looking forward to life in our idyllic, pastoral upstate setting. ■

Bassett itself has changed as well, of course, evolving from a rural community teaching hospital to a healthcare network with multiple affiliated hospitals and numerous regional clinics. We owe a lot to the visionary skills of Bill Streck. However, I would also point out it was Don Pollock, who wore so many hats over the years, that started the first community health center in Cherry Valley.

To look back over a lifetime and suggest that you would do it all over again is not common. I do think I would make the same basic decisions, but only because I was fortunate

over my career to have numerous “enablers”. I mentioned the fundamental importance of my connections with patients. Also invaluable were relationships with my colleagues who have shared the good and not so good times.

Working with John Davis and others to start the Alumni Association back in 1988 provided the ongoing camaraderie of the greater Bassett family. However, the American College of Physicians (ACP) literally saved my life. Early in my career, before we had a name for it, I was completely “burned out”. Depressed really. Thankfully, I was on the receiving end of a program sponsored by the ACP’s Wisconsin chapter that embedded students with practicing internists. Having a medical student join me in rural Wisconsin when I was working there in the years after my residency completely changed everything for me. Likewise, I was beyond fortunate in my involvement with the College (ACP) to have the stars in alignment on more than one occasion which enabled me to serve in various leadership positions. I truly feel that as part of “the conscience of medicine” I was able to facilitate some policies that have had a national impact.

Of course, none of this journey could have been possible without Lynn, my most supportive and forgiving wife. Medicine has a narcissistic streak that can overwhelm a personal relationship if one is not careful. For me, having outside interests has been critical. A friend of mine from ACP days called running the “rhythm of life”. I ran my first marathon after training early every morning on the East Lake Road.

My time in Wisconsin introduced me to Nordic skiing, kept me fit during the winter, connected me with an entirely new group of friends and reinforced my zest for running once the snow melted. Books have been a lifelong passion and helped sustain me throughout.

Medicine has been good to me and it has been an incredible privilege. As I contemplate my imminent retirement, part of me takes satisfaction from generally doing more good than

harm. Another part of me, however, knows that there is so much more to do to develop a truly just, equitable and universal system of healthcare for this country. You never know. Maybe at 69.5 years there is something yet in the tank.

## 1950s

## Alum Calls for Colleagues Feedback

Professor emeritus and Bassett intern from 1956-57, Dr. Charles Greenblatt continues his interest in research. According to Greenblatt, the focus of his current work is trying to understand adult vaccination. He sent the following explanation and asked for readers to respond:

"We have two published articles on the follow-up of superficial bladder cancer patients receiving BCG, and they showed a dramatically reduced incidence of Alzheimer's Disease. Instilling BCG into people's bladders cannot be thought of as a mass public health approach, but Harvard has independently confirmed the bladder cancer results, and is now doing BCG by jab. We got in this business when I read an article from Faustman (Denise Faustman, H.M.S. associate professor of medicine at Mass General) at Harvard claiming that two jabs of BCG brought the glucose values of juvenile diabetes down

to the normal range, and another from Italy arguing that BCG could lengthen the remissions in MS. I felt these non-specific effects of this old TB vaccine needed follow-up. I would love to link up with any of *The Cupola's*

readers who have a "number cruncher" in their group looking at Alzheimer's. BCG may have been given to your Covid-19 caregivers before the specific Covid-19 vaccine was available. ## Bassett Partners with New York State to Staff Mass Vaccination Clinic at SUNY Oneonta

Bassett Healthcare Network is assisting New York State by providing clinical staff at the newly established COVID-19 mass vaccination site at SUNY Oneonta that opened in mid-March.

"Bassett is extremely proud to partner with New York State, SUNY Oneonta, and other key stakeholders in our communities to launch this tremendous operation," says Dr. Tommy Ibrahim, president & CEO of Bassett Healthcare Network. "This is a critical step forward for our region in the fight against COVID-19. We are grateful for all the efforts of the Governor and our State officials who have made this possible."

Bassett Healthcare Network will deploy more than 30 clinical professionals to SUNY Oneonta per day, seven days a week, including physicians, advanced practice clinicians, pharmacists, nurses, pharmacy technicians, and data entry workers. New York State and the National Guard are supplementing daily staffing for administrative tasks like

registration and patient navigation. Local county health departments will also support efforts with organization assistance and patient transportation.

"We've never seen a coordinated public health operation of this scale in the area Bassett serves," says Kelly Rudd, PharmD, Bassett Healthcare Network's director of Pharmacy Services. "The collaboration and support we've received is stunning. Employees across the network are lining up to be part of this incredible effort to prioritize the health of our family, friends, and neighbors." ■

### Lincoln Edward F. Danielski, Jr. M.D.

Dr. Edward F. Danielski, Jr., was born in Greenfield, Mass., on July 12, 1930 and died at his home at age 90 in Cooperstown on February 14, 2021. A graduate of Harvard University, he obtained his medical degree from the College of Physicians and Surgeons of Columbia University in 1957. After residency at Bellevue Hospital, he served in France as Captain, M.C. in the U.S. Army, where he met his wife to be, Anne Marie Philippot de Miniere; they were married in 1960. After obtaining

certification in Radiology, Radiotherapy and Nuclear Medicine in 1964, they moved to Cooperstown where he became associate radiologist at Bassett Hospital, working with Radiologist-in-Chief, Dr. Otto Sahler. In 1969 he left Bassett to establish and direct his own Radiology Department at Fox Hospital in Oneonta, where he worked until his retirement. He was a past president of the Fox Hospital Medical Staff and of the Otsego Chapter of the American Cancer Society. Through the years he also served to establish advances in radiology in the Dominican Republic and Tunisia. He was a gifted piano and harpsichord player. His wife of 60 years, Anne Marie Danielski, had passed away less than two months before his death. They are survived by multiple children and grandchildren.
